

STATEMENT ON THE IMPLEMENTATION OF MIFID II

Madrid, 2 January 2018

The Council of Ministers approved on 29 December a Royal Decree-Law (published in the Official State Gazette of 30 December) that transposes Directive 2014/65/EU (MiFID II) into Spanish law with regard to the regime of trading venues (regulated markets, multilateral trading facilities and organised trading facilities), a key aspect of the Directive.

In relation to the areas that were not covered in said Royal Decree-Law, it is recalled that other parts of the MiFID II-MiFIR regulatory package will also be directly applicable from January 3 2018 (which is the case, for example, of various Regulations), as well as the direct effect that the European Directives can have in certain cases according to the ECJ's case-law. It should also be noted that, in accordance with such case-law, CNMV must promote the effectiveness of the European Directives within the scope of its competences by interpreting the current national regulations in a manner consistent with the Directive.

Taking into account all the above, CNMV understands that relevant entities, infrastructures and other market participants will adjust their organization and activities in general to the set of rules and obligations emanating from MiFID II-MiFIR as of 3 January 2018.

Likewise, it is reported that CNMV has been designated as the competent authority in Spain regarding the various European provisions related to securities markets that are currently being transposed and adapted (MiFID II, MAR, PRIIPS and Benchmarks).

Finally, in order to facilitate market participants to adapt to this regulatory package, CNMV considers it wise to remember the documents that it has disseminated in recent months with criteria and guidelines in this regard:

- Statements and various other documents related to the intention of complying with certain ESMA guides or consisting of technical guides, criteria, Q&As or summaries of the meetings of the implementation group of which sector representatives are part, which can help entities effectively adapt to the aforementioned regulatory package. These documents are listed in annex I.
- A statement intended for entities that may be interested and in general for market participants on a series of actions related to authorisations of new figures or services or communications to be submitted to the supervisor. This statement, which includes a detailed table, is attached as annex II.

The CNMV Secondary Markets Directorate has prepared a table, attached to this communication, which identifies the most relevant actions in relation with MiFID II¹ and MiFIR² (authorization processes, notifications, requests for exemptions, etc.) relating to markets and financial instruments.

The aim is for the information contained in this table to serve as a guide for market participants and other stakeholders for the purpose of carrying out tasks in preparation for the upcoming application of this regulatory framework and its developing rules, some of which are directly applicable.
