In addition to the above, the Company reports that, after the last of the reported acquisitions, the Company has reached the maximum number of shares (800,000 shares, representing approximately 0.18% of the Company's share capital) prescribed in the Repurchase Program. The shares have been acquired for a cash amount of EUR 997,122.71.

Consequently, it is hereby reported that the Repurchase Program has come to an end prior to its maturity.
