Advance Fee Fraud

The Commission has recently become aware of e-mail correspondence which mentions the above website. This website claims to represent Barclays Private Bank at an address of 43-51 Athol Street, Douglas Isle of Man, IM99 1EF.

In the correspondence seen by the Commission they claim there is a fixed deposit of \$6,800,000 which supposedly belongs to a deceased gentleman with no living relatives and they wish to "...transfer custody to you for our mutual benefit.".

There are three genuine Barclays licenceholders on the Isle of Man. They are:

Barclays Bank PLC – Banking licence.

Barclays Private Bank & Trust (IOM) Limited – Banking, Corporate Service Provider, Trust Service Provider licences. Barclays Private Clients International Limited – Banking licence.

We can confirm that none of these genuine entities has an address at 43-51 Athol Street, Douglas Isle of Man, IM99 1EF.

A list of all institutions licensed by the Commission is available on our website at <u>www.fsc.gov.im</u>.

None of the genuine Barclays entities are in any way connected to the above website or fraudulent e-mails.

Under the circumstances the Financial Supervision Commission feels that these e-mails are being issued to tempt the recipient into becoming the victim of an Advance Fee Fraud – see explanatory notice issued by the Commission at:
