IFM GIF holds its interest in Global InfraCo O (2) S.à r.l. through a chain of companies headed by Global InfraCo S.à r.l. In this regard, the Offeror is a company wholly owned by Global InfraCo O (1) S.à r.l., which is, in turn, wholly owned by Global InfraCo Spain, S.L.U., which is, in turn, wholly owned by Global InfraCo NL Coöperatief U.A. Global InfraCo NL Coöperatief U.A. is 99.9995% owned by Global InfraCo S.à r.l., being the outstanding 0.0005% owned by IFM GIF. Finally, Global InfraCo S.à r.l. is wholly owned by IFM GIF.
