



**The Financial Services and Markets Authority (FSMA) warns the public against the fraudulent activities of Laporte Holding, a company that is offering credit illegally to consumers.**

Laporte Holding is not authorized or registered in Belgium as a lender or credit intermediary. **Therefore, Laporte Holding may not offer credit in Belgium.**

According to the information available to the FSMA, it seems that the credit being offered by Laporte Holding is **entirely fraudulent**. The company operates as follows: if a consumer tries to take up the offer, he or she is asked to make certain payments supposedly to cover various **costs** relating to the credit (for example, so-called dossier fees or administrative costs). Once these costs have been paid, the consumer does not receive the credit, and it is almost impossible to recover the sums that were paid. More information about this type of consumer credit fraud is available in the general warning published by the FSMA on 4 October 2019.

Moreover, it seems that this company is related to, of which the FSMA published a in the past.

This company also seems to have links with Mutuels Kredit/Krediet Religieus, for which the FSMA has also issued a [warning](#).

**The FSMA therefore very strongly advises against responding to any offers of credit made by Laporte Holding and against making any payment to the company.**
