However, some firms act without our permission or authorisation and some knowingly run scams.

How to protect yourself

We strongly advise you to only deal with consumer credit firms that have interim permission or are authorised by us, and [check the Financial Services Register](#) [1] and [Consumer Credit Interim Permission register](#) [2] to ensure they are. These registers have information on firms and individuals that are, or have been, regulated by us.

If a firm does not appear on the Register but claims it does, contact our Consumer Helpline on 0800 111 6768.

There are more steps you should take to [protect yourself from unauthorised firms](#) [3].

You should also be aware that if you give money to an unauthorised firm, you will not be covered by the [Financial Ombudsman Service](#) [4] or [Financial Services Compensation Scheme](#) [5] (FSCS) if things go wrong.
