Fitch Downgrades Caja Murcia's Cedulas Hipotecarias to 'AA', Removes RWN

Fitch Patings London 12 January 2011: Fitch Patings has downgraded Cain do Aberras

Fitch Ratings-London-12 January 2011: Fitch Ratings has downgraded Caja de Ahorros de Murcia's (Caja Murcia, rated 'BBB+'/Stable/'F2') mortgage covered bonds (cedulas hipotecarias, CH) to 'AA' from 'AAA' and removed them from Rating Watch Negative.

The rating action follows Fitch's downgrade of Caja Murcia's Long-term Issuer Default Rating (IDR) to 'BBB+' from 'A+' on 11 January 2011 as the Caja was integrated into the newly-formed Banco Mare Nostrum Group (BMNG, rated 'BBB+'/Stable/'F2'; for further information, see "Fitch Rates Spain's Banco Mare Nostrum Group 'BBB+'/Stable; Individual 'C", available at www.fitchratings.com).

Cajamurcia's Long-term IDR of 'BBB+' and the Discontinuity Factor (D-Factor) of 41% for the covered bonds limits their rating to a maximum of 'A+' on a probability of default basis (PD) if overcollateralisation (OC) between the cover assets and the covered bonds is sufficient to sustain this level of stress. In addition, under Fitch's methodology, the rating of the covered bonds can incorporate a credit of up to two notches above the covered bonds' rating on a PD basis if the OC between the cover pool and the covered bonds provides for outstanding recoveries on the covered bonds. All else being equal, the rating of the covered bonds can be maintained at 'AA' as long as the IDR remains at 'BBB+'.

Fitch considers that Cajamurcia's current level of OC (150.6% as of November 2010) is enough to avoid a default on the CH in a 'A+' stress scenario and to provide full recoveries on the CH in a 'AA' stress scenario. The agency will recalculate the level of OC supporting a 'AA' rating for the CH based on the December 2010 cover pool data once it becomes available. The level of OC supporting the rating will be affected, among other factors, by the profile of the cover assets relative to outstanding covered bonds, which can change over time, even in the absence of new issuance. Therefore, it cannot be assumed that the current level of OC supporting the assigned rating will remain stable going forward.

The CHs are collateralised by a pool of mortgage loans originated by Cajamurcia. As of the end of November 2010, the cover pool amounted to EUR11.19bn and the covered bonds to EUR4.464bn The weighted-average (WA) residual maturity of the mortgage assets stood at 15.1 years, whereas the WA residual maturity of the CHs was 5.1 years.
