Financial Regulator Issues Warning on Investment Firms

The Financial Regulator today (Wednesday, 18 February 2009) published a warning notice on two firms, Guardian Asset Management (Japan) and London Equities (Ireland and Belgium). Guardian Asset Management is not authorised as an investment firm in Ireland and has been offering investment services and/or investment advice to members of the Irish public. London Equities is not authorised as an investment firm in Ireland and may be claiming to be an investment firm based here. The notice is published today in Irish daily newspapers under the Markets in Financial Instruments Regulations 2007.

It is a criminal offence for an investment firm to operate in Ireland unless it has an authorisation from the Financial Regulator. Clients of unauthorised firms are not eligible for compensation from the Investor Compensation Scheme.

Any person wishing to contact the Financial Regulator with information regarding such firms may telephone **1890-200-469**. This line is also available to the public to check if an investment firm is authorised. Since obtaining the necessary legal powers in August 1998, 74 warnings naming 136 firms have been issued.
