10. INFORMACIÓN ADICIONAL¹⁸ | ADDITIONAL INFORMATION¹⁸

Following an internal reorganization/simplification, on December 31st 2021, the PRISA shares held by Amber Global Opportunities Limited ("AGOL") and by Amber Active Investors Limited ("AAIL") have been transferred to their respective sub-funds Amber Capital Investment Management ICAV - Amber Global Opportunities Fund ("AGOF") and Amber Capital Investment Management ICAV - Amber Active Investors Fund ("AAIF"). AGOF and AAIF are the 100% shareholders of AGOL and AAIL and managed by Amber Capital UK LLP. As of December 31st, 2021, AGOL held 22,319,173 shares of PRISA, representing 3.15% of the share capital and AAIL held 101,987,187 shares of PRISA, representing 14.39% of the share capital. As a result of the funds' simplification, the shares have been transferred to the correspondent sub-funds and therefore now AGOF holds 22,319,173 shares of PRISA, representing 3.15% of the share capital and AAIF holds 101,987,187 shares of PRISA, representing 14.39% of the share capital. For the sake of completeness, please notice that the total number of shares held by funds managed by Amber Capital UK has not

changed (and remains equal to 211,474,843 shares of PRISA, representing 29.84% of the share capital). The total shares referred to in this disclosure correspond to OVIEDO HOLDINGS SARL, AMBER CAPITAL INVESTMENT MANAGEMENT ICAV - AMBER ACTIVE INVESTORS FUND and AMBER CAPITAL INVESTMENT MANAGEMENT ICAV - AMBER GLOBAL OPPORTUNITIES FUND. Amber Capital UK LLP is the investment manager of OVIEDO HOLDINGS SARL, AMBER CAPITAL INVESTMENT MANAGEMENT ICAV - AMBER ACTIVE INVESTORS FUND and AMBER CAPITAL INVESTMENT MANAGEMENT ICAV - AMBER GLOBAL OPPORTUNITIES FUND and it is vested with discretion to exercise voting rights for the funds under its management pursuant to written investment management agreements. The exercise of the voting rights is also subject to Amber Capital UK LLP's policies and procedures. Joseph Oughourlian is also a director of the issuer.
