

FOURTH SUPPLEMENT DATED 21 JUNE 2022 TO THE BASE PROSPECTUS DATED 15 JULY 2021

This fourth supplement dated 21 June 2022 (the "Supplement") to the base prospectus dated 15 July 2021 (the "Base Prospectus") relating to the €1,000,000,000 Structured Medium Term Note Programme of BBVA Global Markets B.V. (the "Issuer"), comprises a supplement to the Base Prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 (the "Prospectus Regulation") and is prepared in connection with the Structured Medium Term Programme (the "Programme") of the Issuer. This fourth Supplement together with the first supplement to the Base Prospectus dated 5 August 2021, the second supplement to the Base Prospectus dated 16 November 2021, the third supplement to the Base Prospectus dated 24 February 2022 and the Base Prospectus, comprise a base prospectus for the purposes of the Prospectus Regulation.

Terms defined in the Base Prospectus have the same meaning when used in this Supplement. This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus (as so supplemented) issued by the Issuer.

Each of the Issuer and Banco Bilbao Vizcaya Argentaria, S.A. (the "Guarantor") accepts responsibility for the information contained in this Supplement. To the best of the knowledge of each of the Issuer and the Guarantor (which have taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

This Supplement has been approved by the Comisión Nacional del Mercado de Valores (the "CNMV"), as competent authority under the Prospectus Regulation. The CNMV only approves this Supplement as meeting the requirements imposed under Spanish and EU law pursuant to the Prospectus Regulation.

PURPOSE OF THE SUPPLEMENT

The purpose of this Supplement is to (i) incorporate by reference the 2021 Financial Statements of the Issuer (including the auditors' report thereon); and (ii) confirm that there has been no material adverse change in the prospects of the Guarantor and its consolidated subsidiaries (the "Group") since 31 December 2021; and that there has been no significant change in the financial performance or the financial position of the Group since 31 December 2021 and there has been no significant change in the financial or trading position of the Issuer since 31 December 2021.

SIGNIFICANT OR MATERIAL CHANGE STATEMENT

Paragraph 7 of the General Information section on pages 436 and 437 of the Base Prospectus shall be deemed to be deleted in its entirety and replaced by the following wording:

"Save as disclosed in this Base Prospectus, there has been no material adverse change in the prospects of the Group since 31 December 2021 and there has been no material adverse change in the prospects of the Issuer since 31 December 2021.

Save as disclosed in this Base Prospectus, there has been no significant change in the financial performance or the financial position of the Group since 31 December 2021 and there has been no significant change in the financial or trading position of the Issuer since 31 December 2021."

GENERAL

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in or incorporated by reference in the Base Prospectus, the statements in (a) above will prevail.

Save as disclosed in this Supplement there has been no other significant new factor, material mistake or inaccuracy relating to information included in the Base Prospectus since the publication of the Base Prospectus.
