REGULATORY DISCLOSURE

The Company's Board of Directors held on July 23, 2019 approved the execution of the share capital reduction Resolution adopted by the Company's General Shareholders Meeting held on March 5, 2019, through the cancellation of 16,567,195 own shares, each of them of one euro of nominal value, in accordance with the terms and conditions included in the aforementioned Resolution.

The share capital of the Company resulting from the reduction has been set at 984,122,146 Euros, corresponding to 984,122,146 shares, each of them of one euro of nominal value.

The share capital reduction announcements will be published today in the "Boletín Oficial del Registro Mercantil" and on the Company's corporate website (www.naturgy.com).

Subsequently, the corresponding public deed of share capital reduction and modification of Company's Bylaws will be issued and registered at the "Registro Mercantil de Madrid". The 16,567,195 cancelled shares will be then delisted from the Madrid, Barcelona, Bilbao and Valencia Stock Exchanges, through the "Sistema de Interconexión Bursátil (Mercado Continuo)".
