How to protect yourself

We strongly advise you to only deal with financial firms that are authorised by us, and check the <u>Financial Services Register</u> [1] to ensure they are. It has information on firms and individuals that are, or have been, regulated by us.

If you want to check a consumer credit firm that may not yet have been authorised by us, please also check the <u>Interim Permission Register</u> [2].

If a firm does not appear on the Register but claims it does, contact our Consumer Helpline on 0800 111 6768.

There are more steps you should take to <u>avoid scams and unauthorised firms</u> [3].

You should also be aware that if you give money to an unauthorised firm, you will not be covered by the <u>Financial Ombudsman Service</u> [4] or <u>Financial Services Compensation Scheme</u> [5] (FSCS) if things go wrong.

Report an unauthorised firm

If you think you have been approached by an unauthorised firm or contacted about a scam, you should contact our Consumer Helpline on 0800 111 6768. If you were offered, bought or sold shares, you can use our <u>reporting</u> form [6].
