The prospectus, which contains the terms and conditions of the share capital increase, as well as the procedure for subscription and payment of the shares issued under said share capital increase, is available electronically on the webpage of the Company (www.prisa.com) and the CNMV (www.cnmv.es).

In accordance with the prospectus, it is expected that the preferential subscription period of the share capital increase will start on 23 March 2019, once the publication of the mandatory announcement in the Spanish Commercial Registry Official Gazette (*Boletín Oficial del Registro Mercantil*) takes place (scheduled for tomorrow, 22 March 2019).
