- **New labour agreement with flight attendants, still negotiating with pilots**

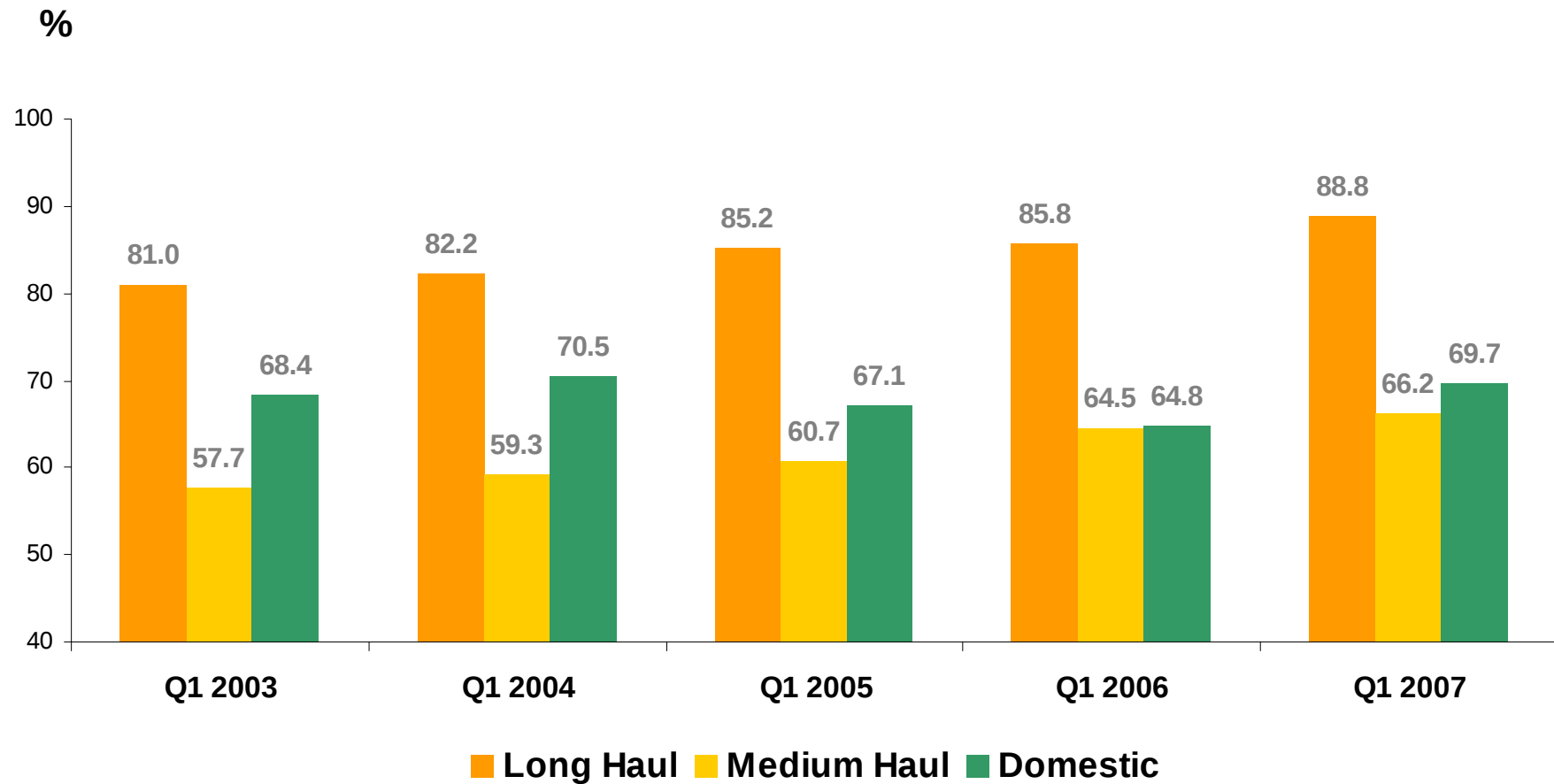

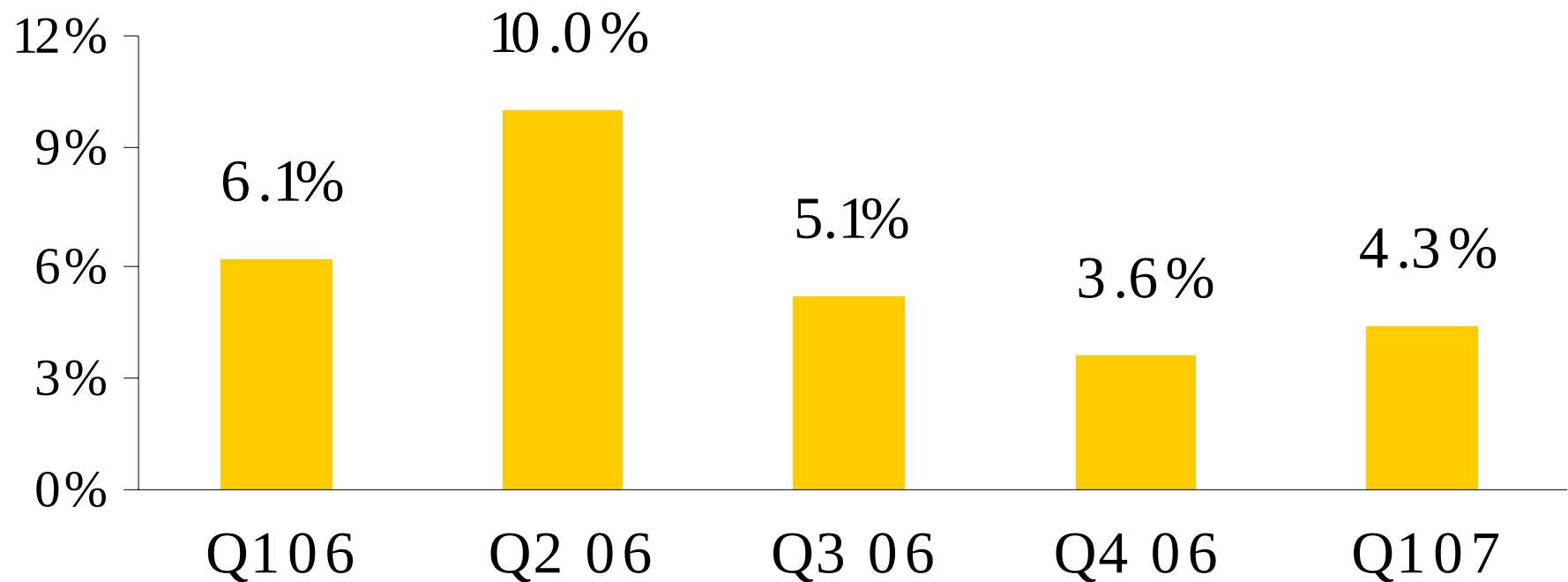
Improvement in Load Factor



UNIT REVENUE EVOLUTION

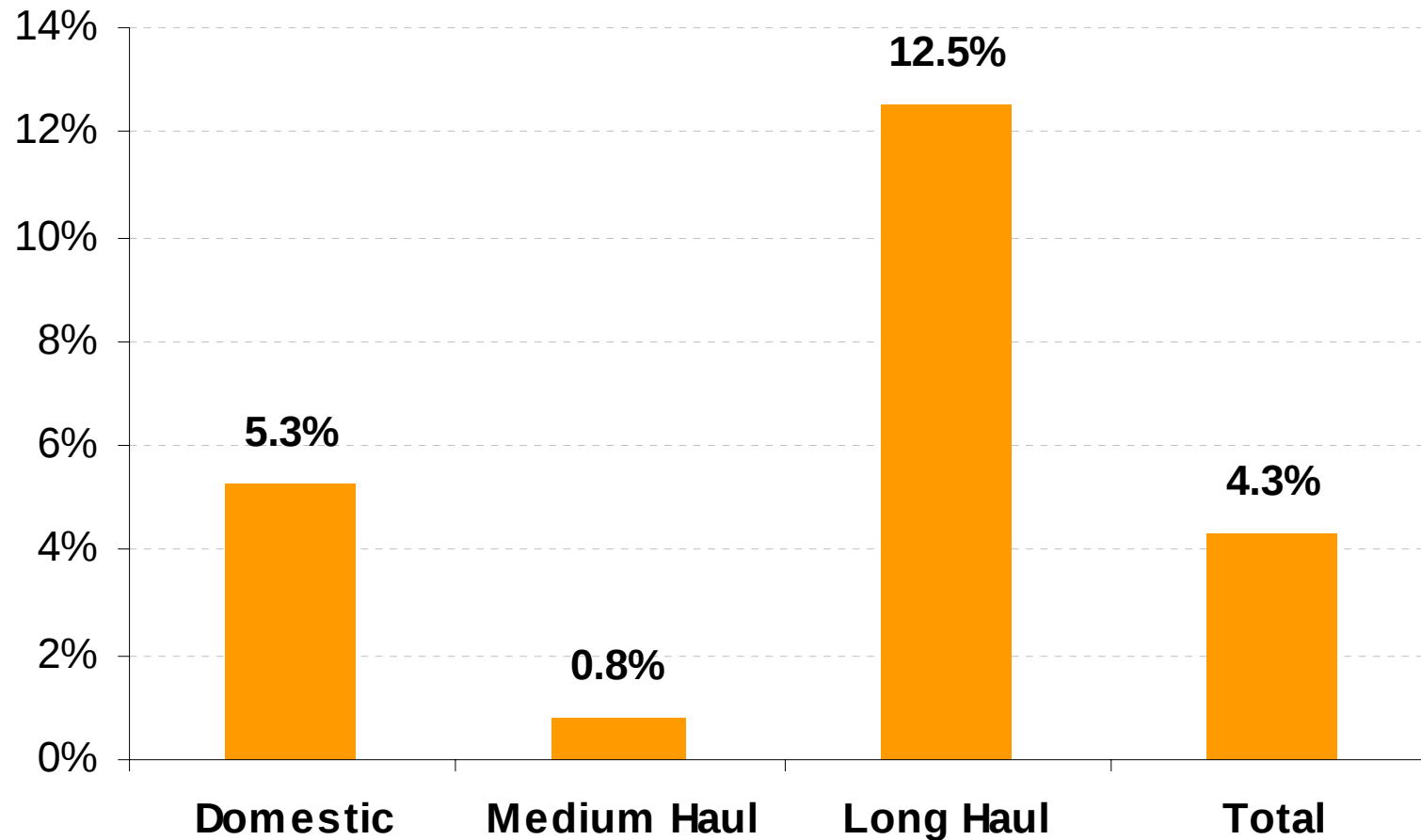
Q1 2007 vs. Q1 2006

Passenger revenue/ASK



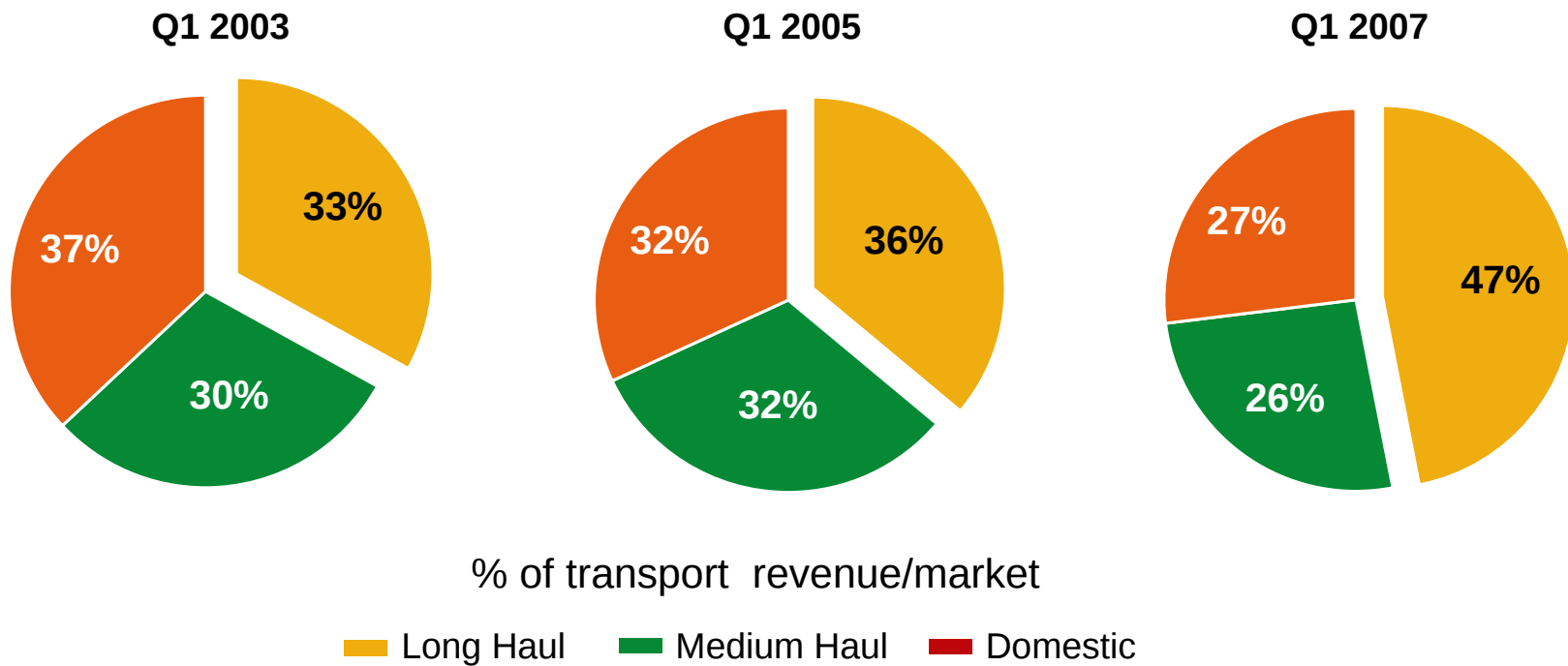
Unit Revenue Evolution Q1 2007 vs. Q1 2006

Long haul is gradually increasing its weight

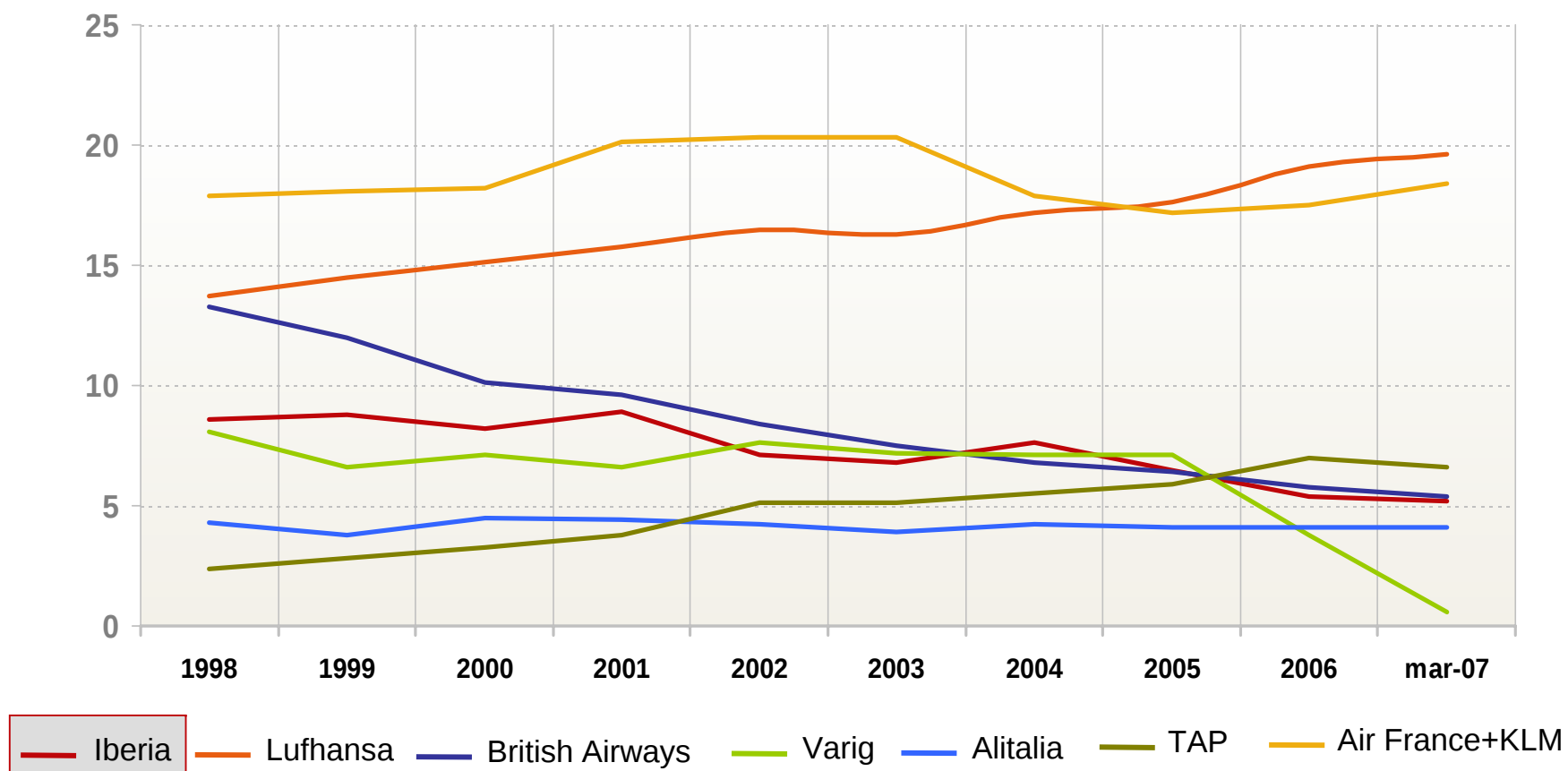

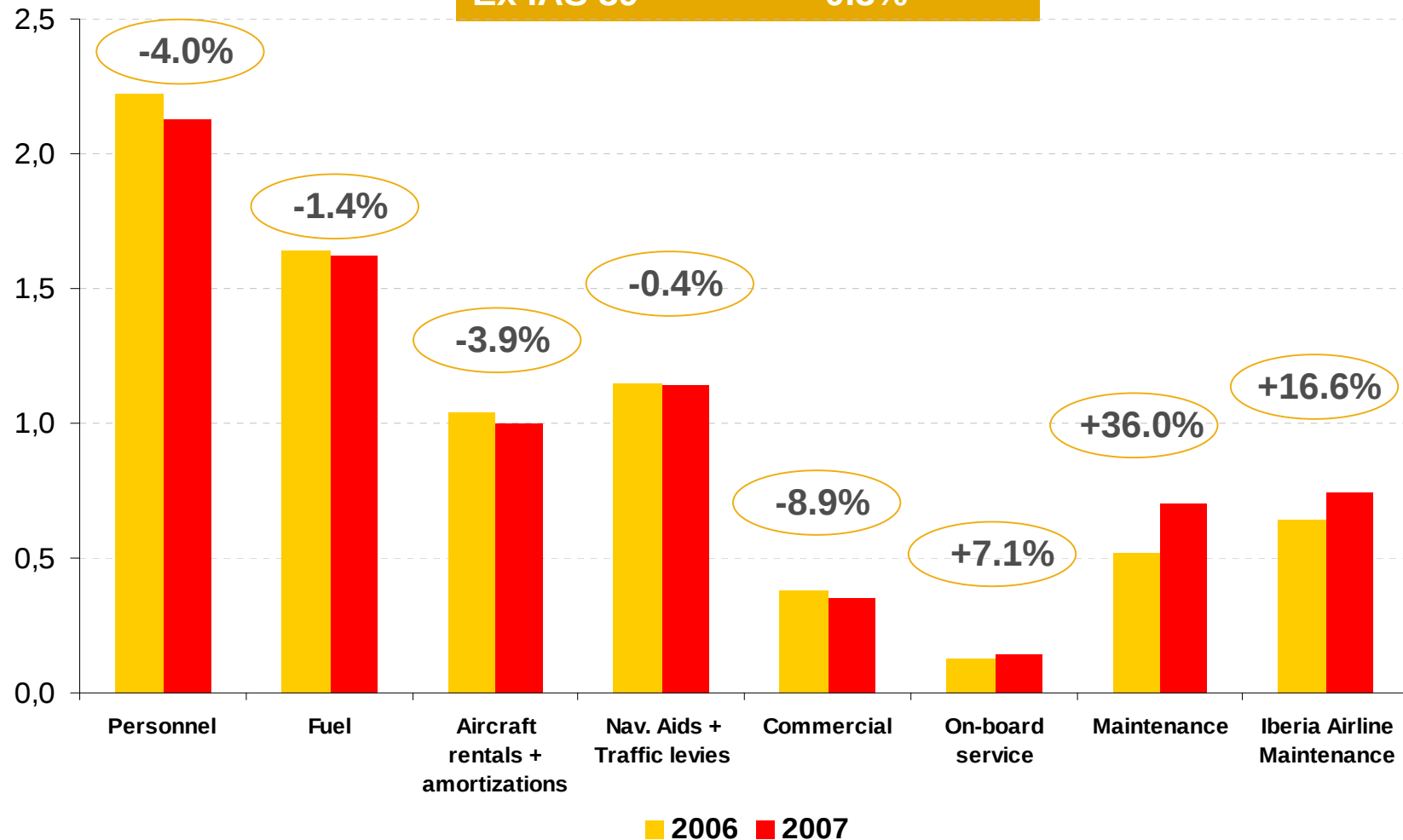

Unit Costs Evolution

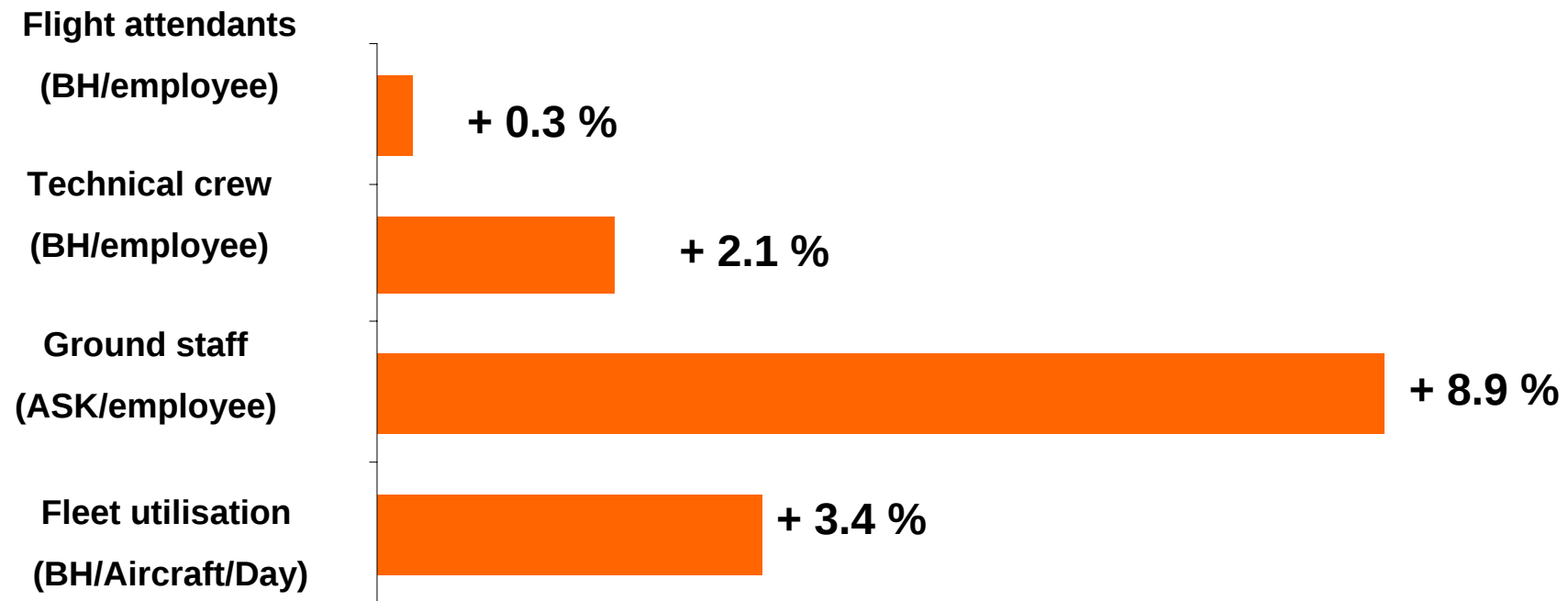

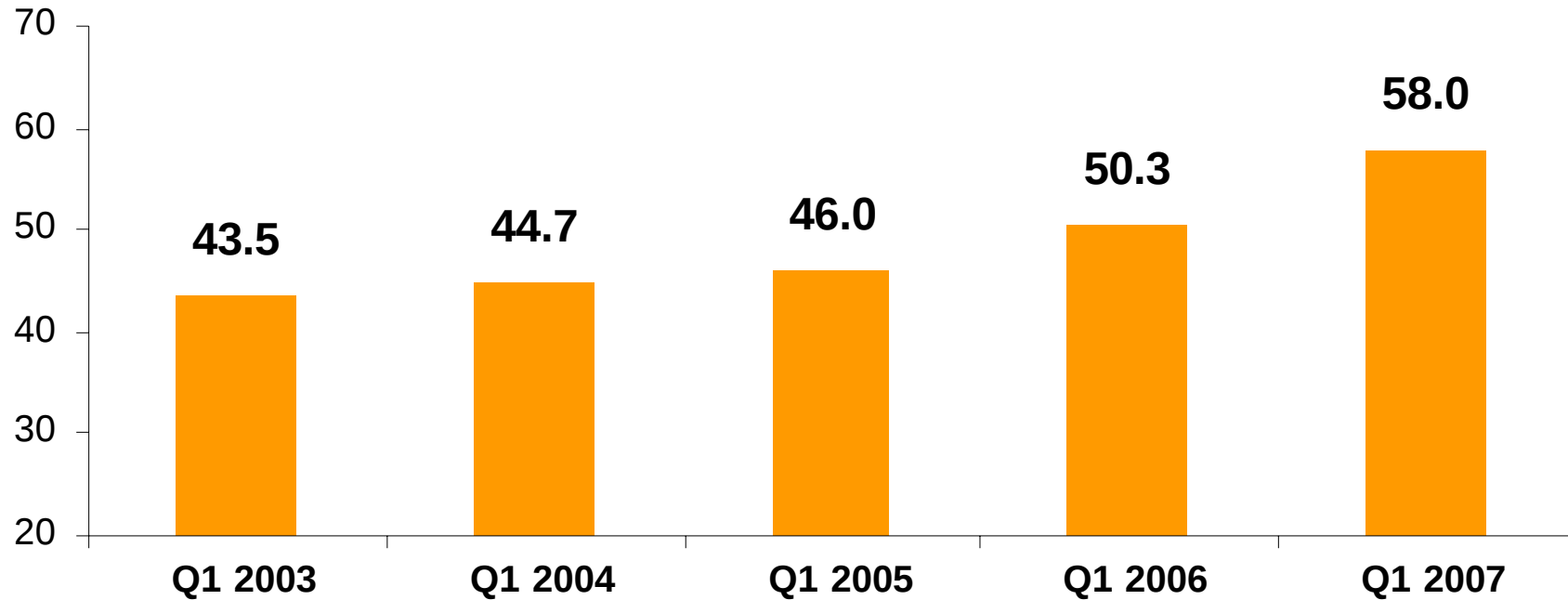


Productivity Q1 2007 vs. Q1 2006
