SBI INDIRECTLY HAS 59% OF THE SHARE CAPITAL AND VOTING RIGHTS IN THE ISSUER WHICH IS HELD AS FOLLOWS: (I) 30.123% IS HELD THROUGH SIEMENS GAS AND POWER GMBH & CO. KG ("SIEMENS KG"). SBI WHOLLY OWNS SIEMENS G. IN ADDITION TO THE ABOVE, THE SOLE GENERAL PARTNER AND MANAGEMENT COMPANY OF SIEMENS KG, THE ENTITY SIEMENS GAS & POWER MANAGEMENT GMBH, WHICH REPRESENTS SIEMENS KG AND THEREFORE HAS THE DISCRETION TO EXERCISE THE VOTING RIGHTS OF SIEMENS KG, IS FULLY-OWNED BY AND UNDER THE CONTROL OF SBI. SIEMENS KG HAS 30.123% OF THE SHARES IN THE ISSUER. (II) 28.877% IS HELD THROUGH KYROS 63 GMBH ("KYROS") WHICH IS WHOLLY OWNED BY SBI AND HAS 28.877% OF THE SHARES IN THE ISSUER.

THIS NOTIFICATION IS MADE BY SAG, AS PARENT COMPANY, ON BEHALF OF KYROS AND SBI AS A RESULT OF (I) KYROS ACQUIRING A SHAREHOLDING IN THE ISSUER ABOVE THE THRESHOLD OF 25% OF THE SHARE CAPITAL AND VOTING RIGHTS;

AND (II) SBI'S SHAREHOLDING IN THE ISUER INCREASING ABOVE THE THRESHOLD OF 50% OF THE SHARE CAPITAL AND VOTING RIGHTS. THE CROSSING OF THE THRESHOLDS IS THE RESULT OF AN INTERNAL REORGANISATION WITHIN THE SIEMENS GROUP AS FOLLOWS: (I) THE TRANSFER OF 28.877% OF THE SHARES IN THE ISSUER FROM SBI TO KYROS (WHICH IS A 100% DIRECT SUBSIDIARY OF SBI); AND (II) THE CONTRIBUTION BY SAG OF ITS STAKE IN SIEMENSKG AND SIEMENS GAS & POWER MANAGEMENT GMBH INTO SBI.
