Additionally, Morgan Stanley & Co. International plc, a wholly owned subsidiary of Morgan Stanley, has crossed relevant thresholds in its own right at component level. The notification was mainly triggered due the return of shares previously loaned to other market counterparties over which Morgan Stanley had retained the right to recall.
