The transactions were predominately the result of hedges to client facing derivatives. Morgan Stanley continues to hold 1,361,538 ARIMA REAL ESTATE SOCIMI, S.A voting rights (4,789%) in its trading book, as defined under Regulation (EU) 575/2013 and is therefore able to apply the exemption available under article 33.4 of Royal Decree 1362/2007 to this holding.
