Changes to the performance fees charged by certain sub-funds of J O Hambro Capital Management Umbrella Fund PLC

We are writing to you as a shareholder in one of the sub-funds of J O Hambro Capital Management Umbrella Fund PLC to advise you of a change to the fees charged in respect of certain Class A Shares or Class X Shares of the following sub-funds:

JOHCM Asia ex-Japan Fund

JOHCM Asia ex-Japan Small and Mid-Cap Fund

JOHCM European Select Values Fund

JOHCM Global Emerging Markets Opportunities Fund (each a "Fund" and collectively the "Funds").

This letter is important and requires your attention but does not require you to take any action.

We have decided to remove the performance fee payable out of each of the Funds to Perpetual Investment Services Europe Limited (the "Investment Manager") in respect of certain Class A Shares or Class X Shares (as shown in the Schedule). The Investment Manager will instead only receive an annual management charge out of the Fund for its services. This change takes effect from the 2 October 2023 (the "Effective Date").

The attached schedule shows the current fees charged and the fees to be charged from the Effective Date. From the Effective Date, these will be incorporated into a new version of the prospectus of the Fund, and this will be available online at https://www.johcm.com.
