Mubadala Petroleum & Petrochemicals Holding Company LLC voting rights in Enagás, S.A. are limited as per article 6 Bis of the by-laws of Enagás, S.A. (vid. Infra) and applicable regulations. As such, the responses in section 7 are qualified. By-laws of Enagás, S.A. Article 6 Bis: No individual or corporate body may directly or indirectly hold more than five per cent of the share capital of the Company or exercise more than three per cent of the voting rights. These shares may not be syndicated for any purpose. Any parties that operate within the gas sector, including those natural persons or corporate bodies that directly or indirectly possess equity holdings in the former of more than five per cent, may not exercise more than one per cent of voting rights. These

restrictions shall not apply to direct or indirect equity held by public-sector enterprises. Equity holdings may not be syndicated for any purpose. Likewise, the combined total of direct or indirect equity held by parties that operate within the natural gas sector may not exceed 40 per cent. For the purposes of calculating the equity holdings in the Company, the laws governing the Spanish hydrocarbons sector shall apply.
