SHARE BUY BACK PROGRAM

This communication refers to the communications of December 10 and 13, 2021 with registration numbers OIR 13123 and OIR 13165 respectively, related to the Naturgy Energy Group, S.A. ("Naturgy") buyback program on own shares ("Shares") for delivery to those Group employees in Spain in active employment who choose to receive part of their salary in Shares.

Pursuant to article 227 of the consolidated text of the Securities Market Law, approved by Royal Legislative Decree 4/2015, of October 23, in article 5 of Regulation (EU) No. 596/2014 on market abuses and in the Delegated Regulation (EU) 2016/1052 of the Commission, of March 8, 2016, we hereby inform of the main data on the execution of the Share buyback program:
