

CaixaBank, S.A. (“**CaixaBank**” or the “**Company**”), in accordance with applicable legislation in the securities market, hereby reports the following information:

Other material information

Further to the Inside Information filing of 30 January 2025 (registration number 2,564) and Other Relevant Information filing of 16 June 2025 (registration number 35,289), relating to the approval and commencing for a programme for the repurchase of own shares for a maximum amount of 500 million euros (the “**Buy-back Programme**”), the Company reports that, after the latest purchases detailed below, the maximum investment provided for under the Buy-back Programme has been reached; that is, 500 million euros, resulting in the purchase of a total of 61,044,767 own shares, which represent 0.86% of CaixaBank’s share capital.

All the share purchases made under the Buy-back Programme have taken place and been communicated on a regular basis, pursuant to Article 5 of Regulation (EU) No 596/2014 of the European Parliament and of the Council of 16 April 2014 on market abuse (“**Regulation on Market Abuse**”), and Articles 2.2 and 2.3 of Commission Delegated Regulation (EU) No 2016/1052 of 8 March 2016 (“**Delegated Regulation**”). As a consequence of the foregoing, the Buy-back Programme has ended.

As reported in the Inside Information filing of 30 January 2025, the Buy-back Programme purpose was to reduce CaixaBank’s share capital through the cancellation of the treasury shares acquired within the framework of the programme, under the capital reduction agreements approved by the General Shareholders’ Meeting. To this end, once the Buy-Back Programme has ended, the approval and formalization for the share capital reduction will be reported to the market in due course.

Moreover, pursuant to Article 5 of Regulation on Market Abuse, and Articles 2.2 and 2.3 of Delegated Regulation, CaixaBank hereby reports that it has carried out the following transactions in its own shares on 21 November 2025, based on the information received from Goldman Sachs Bank Europe SE, as manager of the share Buy-back Programme:
