Almirall, S.A. (the "**Company**"), in accordance with the provisions of Article 227 of Law 6/2023 of 17 March on the Securities Market and Investment Services, and related provisions, hereby gives notice of the following

## OTHER RELEVANT INFORMATION

Further to our other relevant information notice published today in connection with the informative document regarding the Company's flexible dividend system (registration number 2024063981), the Company announces the expected timetable for the implementation of the paid-up capital increase approved by the Ordinary General Shareholders' Meeting held on 10 May 2024 under item thirteen of the agenda and executed by the Board of Directors by means of a resolution of the same date, through which the flexible dividend system is instrumented, which will offer shareholders the option to receive the agreed dividend in cash and/or in shares:

- <u>10 May 2024</u>. Capital increase resolution. Determination of the number of rights required to receive one share and the final price of the rights purchase commitment<sup>1</sup>. The price of the rights purchase commitment is calculated considering the arithmetic mean of the weighted average prices of the Company's share on the Spanish Stock Exchanges in the 5 trading sessions prior to the resolution of the Board of Directors to carry out the capital increase (i.e. the sessions of 3, 6, 7, 8 and 9 May 2024).
- <u>16 May 2024</u>. Publication of the announcement of the capital increase in the Official Gazette of the Commercial Registry (*BORME*). Last trading day of the shares of Almirall eligible to participate in the flexible dividend programme (last trading date). Almirall shareholders who have acquired their shares up to that date (inclusive), and who are registered as shareholders in *Sociedad de Gestión de los Sistemas de Registro, Compensación y Liquidación de Valores, S.A.U.* (Iberclear) records on 20 May 2024, will be entitled to participate in the flexible dividend system.
- <u>17 May 2024</u>. Beginning of the trading period of the free-of-charge allocation rights and of the period to request the remuneration in cash. Date from which (inclusive) Almirall shares trade ex-coupon (ex-date).
- <u>27 May 2024</u>. End of the period to request the remuneration in cash by virtue of the rights purchase commitment assumed by Almirall.

<sup>&</sup>lt;sup>1</sup> The rights purchase commitment will only be applicable in respect of the rights received by shareholders who have acquired their Almirall shares no later than 16 May 2024 (last trading date), and who are registered as shareholders in the records of Sociedad de Gestión de los Sistemas de Registro, Compensación y Liquidación de Valores, S.A.U. (Iberclear) on 20 May 2024 (record date), but not in respect of those acquired in the market.



- <u>3 June 2024</u>. End of the trading period for the free-of-charge allocation rights. Acquisition by Almirall of the free-of-charge allocation rights of those shareholders who have requested their purchase by Almirall pursuant to the purchase commitment.
- <u>**4 June 2024.</u>** Waiver by Almirall of the free-of-charge allocation rights acquired by virtue of the purchase commitment and closing of the capital increase.</u>
- <u>5 June 2024</u>. Payment in cash to shareholders who opted to sell the free-of-charge allocation rights to Almirall under the purchase commitment. Communication of the final result of the transaction.
- **From 6 June 2024.** Procedures for registration of the capital increase and admission to trading of the new shares on the Spanish Stock Exchanges.
- <u>12 June 2024</u><sup>2</sup>. Estimated starting date of ordinary trading of the new shares on the Spanish Stock Exchanges, subject to the relevant authorisations being obtained.
