



**FERROVIAL SE ("FERROVIAL" OR THE "COMPANY") ANNOUNCES TRANSACTIONS
UNDER THE SHARE BUYBACK PROGRAM**

Amsterdam, 17 September 2025

Ferrovial (Ticker: "FER") refers to (i) the announcement disclosed to the market on 14 March 2025, regarding the implementation of a buyback program for its own shares (the "Program"), starting on 2 June 2025; and (ii) the announcement disclosed to the market on 9 September 2025, reporting the transactions under the Program between 1 and 5 September 2025.

An error was detected in the latter announcement regarding the total amount disbursed for the acquisition of Ferrovial shares. The information from that period can be found below again, including the correct data.

The Company reports that, during the period between 1 and 5 September 2025, it has carried out the following transactions under the Program.
