Pursuant to article 226 of Law 6/2023 of 17 March, on Securities Markets and Investment Services, and as a continuation of the pre-stabilisation period announcement dated 14 November 2024 (with number 2,467), Cox ABG Group, S.A. (the "**Company**") hereby informs that Banco Santander, S.A., in its capacity as stabilising agent (the "**Stabilising Agent**") within the framework of the offer for subscription of ordinary shares of the Company (the "**Offer**"), has today notified, acting on behalf of the managers of the Offer, the decision to partially exercise the subscription option (green-shoe) granted by the Company with respect to 185,025 ordinary shares of the Company (representing 0.24% of its current share capital). The subscription price of said shares corresponds to the Offer price, i.e., EUR 10.23 per share.

The Company also informs that the stabilisation period concludes today. In compliance with Article 6.3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016, the Company hereby informs that during the stabilization period the Stabilising Agent has undertaken stabilisation transactions in accordance with the relevant provisions of Regulation (EU) 596/2014 of the European Parliament and of the Council of 16 April 2014 on market abuse as set out below.
