The Company hereby informs you that in accordance with the provisions of section 2 of Rule Four of Circular 1/2017, of 26 April, of the Spanish National Securities Market Commission, on liquidity contracts (the "Circular 1/2017"), the Company has entered into a liquidity agreement (the "Liquidity Agreement") on 11 December with the company ALANTRA EQUITIES SOCIEDAD DE VALORES S.A. (the "Financial Intermediary").") whose operations will begin once the Pre-period has ended, communicated by means of Other Relevant Information number 38100, also dated December 11, 2025.

For the purposes of the provisions of section 2.a) of the aforementioned Fourth Rule, the following is reported:

- 1. Value subject to the Liquidity Agreement: Shares of Línea Directa Aseguradora, S.A. (ISIN ES0105546008).
- 2. Markets in which the operations will be carried out: The operations will be carried out on the Madrid, Barcelona, Bilbao and Valencia Stock Exchanges through the Stock Exchange Interconnection System (Continuous Market).
- 3. Period of validity of the Liquidity Agreement: 12 months, extendable for the same period.
- 4. Final number of shares allocated to the liquidity contract and deposited in the securities account associated with it: 489,817 shares. It is included in a summary of the operations carried out in the previous period (**Annex**).
- 5. Amount of the final cash allocated to the liquidity contract and deposited in the cash account associated with it: 549,574.67 euros.
