In compliance with the information duties set out in article 17 of the EU 596/2014 Council and Parliament Regulations of 16 April 2014 on market abuse and article 226 of Law 6/2023, of 17 March, on securities markets and investment services (*Ley 6/2023, de 17 de marzo, de los Mercados de Valores y de los Servicios de Inversión*) and further to the price sensitive information communication number 3023 published on 3 December 2025, regarding the sale of approximately 4.29 million shares of CIE Automotive, S.A. (“**CIE Automotive**”) held by Mahindra Overseas Investment Company (Mauritius), LTD (the “**Selling Shareholder**”) (the “**Sale**”), BNP PARIBAS and J.P. Morgan on behalf of the Selling Shareholder hereby announce that the accelerated book-building process has been completed and the final terms of the Sale have been determined.

Pursuant to the Sale, the Selling Shareholder has sold 4,288,596 shares representing circa 3.58% of the share capital of CIE Automotive at a sale price of EUR 27.75 per share.

BNP PARIBAS and J.P. Morgan have acted as joint global coordinators in the Sale (the “**Joint Global Coordinators**”).

Following settlement of the Sale, the Selling Shareholder will hold 4,288,595 shares (representing circa 3.58% of the share capital of CIE Automotive) which will be subject to a 60 day lock-up, subject to certain exceptions.

The distribution of this announcement and the offer and sale of the shares of CIE Automotive (the “Shares”) in certain jurisdictions may be restricted by law and persons into whose possession this document or other information referred to herein comes should inform themselves about and observe any such restriction. Any failure to comply with these restrictions may constitute a violation of the securities laws of any such jurisdiction.

The Shares are not being offered to the public in any jurisdiction and may not be offered to the public in any jurisdiction in circumstances which would require the preparation or registration of any prospectus or offering document relating to the Shares in such jurisdiction. This announcement is not an offer of securities for sale in any jurisdiction, including the United States, Australia, Canada, Japan or South Africa. No action has been taken by the Seller, the Joint Global Coordinators or any of their respective affiliates to permit a public offering of the Shares or possession or distribution of this announcement in any jurisdiction where action for that purpose is required. Neither this announcement nor anything contained herein shall form the basis of, or be relied upon in connection with, any offer or purchase whatsoever in any jurisdiction and shall not constitute or form part of an offer to sell or the solicitation of an offer to buy any securities in the United States or in any other jurisdiction.

The securities referred to herein have not been and will not be registered under the U.S. Securities Act of 1933, as amended (the “Securities Act”), and may not be offered, sold or transferred, directly or indirectly, within the United States, except pursuant to an exemption from, or in a transaction not subject to, the registration requirements of the Securities Act and the securities laws of any state or other jurisdiction of the United States. There will be no public offering of the Shares in the United States.

No registration pursuant to Article 4, paragraph 1 of the Financial Instruments and Exchange Act of Japan (Law No. 25 of 1948, as amended) (the “FIEA”) has been made or will be made with respect to the solicitation of the application for the acquisition of the Shares as such solicitation falls within a Solicitation for Small Number Investors (as defined in Article 23-13 paragraph 4 of the FIEA).

In member states of the European Economic Area (the “EEA”), this announcement and any offer if made subsequently is directed exclusively at persons who are “qualified investors” within the meaning of the Prospectus Regulation (Regulation (EU) 2017/1129) (“Qualified Investors”). In addition, the Joint Global Coordinators and their respective affiliates may enter into financing arrangements (including swaps or contracts for differences) with investors in connection with which the Joint Global Coordinators and any of their respective affiliates may from time to time acquire, hold or dispose of Shares. The Joint Global Coordinators do not intend to disclose the extent of any such investment or transactions otherwise than in accordance with any legal or regulatory obligations to do so.
