### OTHER RELEVANT INFORMATION

#### Operations liquidity agreement

On June 25, 2021, Pharma Mar, S.A. entered into a liquidity agreement with JB CAPITAL MARKETS, SOCIEDAD DE VALORES, S.A.U. in order to promote the liquidity of the transactions and the regularity of the listing of its shares, which entered into force on June 28, 2021 and whose operation would be effective as of 13 July 2021, as communicated to the market through other relevant information of this date (with registration number 10,583). Subsequently, on June 30, 2026, the Company resolved to temporarily suspend the aforementioned liquidity agreement, effective as of the close of trading on that same day, June 30, 2026, in order to carry out the acquisition of treasury shares pursuant to the authorization granted by the General Shareholders' Meeting held on June 30, 2026, as disclosed to the market through other relevant information of June 30, 2026 (registration number 41636).

In compliance with the provisions of section 2.b) of Rule Fourth of Circular 1/2017, of 26 April, of the National Securities Market Commission, on liquidity agreements, below are detailed the operations carried out under the aforementioned liquidity agreement corresponding to the period between 1 April 2026 and 30 June 2026.
