With regard to the other relevant information notice dated 29 May 2025 (registration number 35,049) relating to the implementation of a share buyback program (the “**Buyback Program**”), and in compliance with the provisions of Articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of March 8, 2016, supplementing Regulation (EU) No. 596/2014 on market abuse (“**RAM**”) with regard to technical regulatory standards on the conditions applicable to share buyback programs and stabilization measures (the “**Delegated Regulation 2016/1052**”), eDreams informs that, following the last of the acquisitions referred to below, the maximum monetary amount provided for under the Buyback Program has been reached, with a total of 2,403,805 treasury shares representing approximately 1.93% of the Company’s share capital having been acquired. As a result of the above, the Buyback Program is successfully completed in accordance with the terms set forth therein.

Following the transactions reported on 8 September 2025 through other relevant information notice (registration number 36,579), during the period between 8 September 2025 and 10 September 2025, the Company has carried out the following transactions on its own shares under the Buyback Program:
