

**FERROVIAL SE ("FERROVIAL" OR THE "COMPANY") ANNOUNCES TRANSACTIONS
IN OWN SHARES**

Amsterdam, 27 December 2023.

Ferrovial (Ticker: "FER") refers to the announcement disclosed to the market on 30 November 2023 regarding the implementation of a buy-back program for its own shares to reduce the Company's share capital (the "**Program**").

Pursuant to articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016, supplementing Regulation (EU) No 596/2014, of the European Parliament and of the Council, with regard to regulatory technical standards for the conditions applicable to buy-back programs and stabilisation measures, it is reported that during the period between 19 and 22 December 2023 Ferrovial has carried out the following transactions over its own shares under the Program.
