Likewise, we inform you that, after the last of the above-mentioned acquisitions, the Company reached the maximum number of shares to be acquired under the Acquisition of Treasury Shares, that is, 90,000 shares for a total amount of €7,035,293.74, and that, therefore, its termination occurs before the deadline for its effectiveness (set for June 30, 2026). These shares represent 0.5% of the Company's share capital at the date of this communication.



Additionally, it is hereby communicated that, after the completion of the Acquisition of Treasury Shares, the suspension of the operations regulated in the liquidity agreement entered into the Company and JB CAPITAL MARKETS, SOCIEDAD DE VALORES, S.A.U., which entered into force on June 28, 2021 and whose operation would be effective as from July 13, 2021, as was communicated to the market through other relevant information of this date (with registration number 10,583) will cease. Consequently, these operations will be resumed as from March 30, 2026.
