Regarding the liquidity contract signed with JB Capital Markets, Sociedad de Valores, S.A.U., (the "**Liquidity Contract**") initially signed in July 2019 (communicated to the market through the publication of the corresponding "relevant fact" registration number 280677) and which has been extended by agreement between the parties successively, the last in July 2025 (effective until July 11, 2026), and in accordance with the provisions set forth in Rule Fourth, limb 2, b) of Circular 1/2017 of 26 April, of the Spanish National Security Market Commission (*Comisión Nacional del Mercado de Valores*) on liquidity contracts, a summary of the operations carried out under the aforementioned Liquidity Contract for the third quarter of the fiscal year of 2025 (since 1 July 2025 until 30 September 2025) is hereby included.
