Following article 17 of Regulation (EU) 596/2014 on Market Abuse, articles 227 and 228 of the Royal Legislative Decree Law 4/2015, dated October 23, approving the consolidated text of the Securities Market Law and other applicable legislation, CIE Automotive, S.A. (hereinafter, the 'Company') releases the execution, on the date hereof, of an agreement to acquire, through its Brazilian subsidiary Autometal Ltda, 100% of the share capital of the Brazilian company Weidplas Brasil Indústria e Comércio De Plásticos Ltda ('Techniplas Brazil'), a Brazilian subsidiary of the Techniplas group.

With around 600 employees and sales in 2024 of approximately 50 million euros, Techniplas Brazil has a plant in Piracicaba, in the state of São Paulo, and specialises in the manufacture of highly complex plastic components, including decorative parts and functional components, integrating injection, bi-injection or dual injection, painting and assembly processes.

The enterprise value of the transaction amounts to around EUR 65 million - equivalent to around 5 times the current year's EBITDA of Techniplas Brazil -.

The price of the transaction will be paid in cash at closing and by means of cash currently available.

The closing of the transaction is conditional upon clearance of the transaction by the Brazilian antitrust authorities.

## CIE AUTOMOTIVE ACQUIRES BRAZILIAN COMPANY TECHNIPLAS

## The integrated company specialises in the manufacture of plastic components and supplies leading OEMs.

Bilbao, 17.06.2025 - CIE Automotive announced today the acquisition of 100% of the share capital of Weidplas Brasil Indústria e Comércio De Plásticos, Ltda. (hereinafter, 'Techniplas Brazil'), a Brazilian subsidiary of the Techniplas Group.

The enterprise value of the transaction amounts to around EUR 65 million - equivalent to around 5 times the current year's EBITDA.

The price of the transaction will be paid in cash at closing and by means of cash currently available.
