The Company informs about the implementation of a Buy-back Program over the Company's own shares pursuant to the authorization granted by the general meeting of shareholders held on September 27, 2024 (the "Buyback Program"), subject to the provisions of Article 5 of the Market Abuse Regulation (EU) No. 596/2014 ("MAR") and Article 2 of the Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016 supplementing the MAR as regards regulatory technical standards concerning the conditions applicable to buy-back programs and stabilization measures (the "Delegated Regulation 2016/1052"), as well as other applicable legislation.

The Buy-back Program shall be carried out in the following terms:

- **1. Purpose.** The purpose of the Buyback Program is to reduce the share capital of the Company through the redemption of the acquired shares.
- **2. Maximum monetary amount.** The maximum monetary amount of the Buyback Program is 20,000,000 euros.
 - In any case, the par value of the treasury shares acquired directly or indirectly by the Company, added to those already held by the Company from time to time and, if applicable, its subsidiaries, cannot exceed 10% of the Company's subscribed capital.
- **3. Maximum number of shares to be acquired**. The Buyback Program will affect a maximum of 3,600,000 treasury shares, representing 2.96% of the Company's current share capital.
 - In any case, the par value of the treasury shares acquired directly or indirectly by the Company, added to those already held by the Company from time to time and, if applicable, its subsidiaries, cannot exceed 10% of the Company's subscribed capital.
- **4. Price and volume.** The shares shall be purchased at market price, in accordance with the price and volume conditions set forth in Article 3 of Delegated Regulation 2016/1052.
- **5. Duration.** The Buy-back Program shall be in force for a maximum term of one year from the effective date, unless prior to such date (i) the maximum number of shares has been reached, (ii) shares have been acquired for the maximum amount indicated, or (iii) if other circumstances so advise.
- 6. Communications. The interruption, termination or modification of the Buy-back Program, as well as the share purchase transactions carried out thereunder, shall be duly communicated to the National Securities Market Commission by means of the corresponding other relevant information communication with the periodicity provided for in Delegated Regulation 2016/1052. The Buy-back Program shall commence with the

publication of this communication of other relevant information.

7. Management of the Program. The management of the Buy-back Program has been entrusted to Deutsche Bank AG, which will make the share purchases on behalf of the Company and will make all decisions to purchase the Company's shares independently of the Company.
