ACCIONA Energía informa de que ha alcanzado un acuerdo con OTRAS PRODUCCIONES DE ENERGÍA FOTOVOLTAICA, S.L.U. (OPDE), para la venta del 100% de diversas sociedades del grupo ACCIONA Energía, titulares directamente de 13 parques eólicos en operación en España con una potencia consolidada de 440 MW, por un importe aproximado de 530 millones de euros. El acuerdo incluye, además, una cartera de proyectos fotovoltaicos en desarrollo de hasta 351MWp, asociada al potencial de hibridación de los parques eólicos incluidos en la operación.

Se estima que la operación generará a ACCIONA Energía un resultado de 190 millones de euros.

El cierre de la operación está sujeto al cumplimiento de condiciones suspensivas de carácter regulatorio, estando previsto el mismo durante el segundo semestre del ejercicio en curso.

ACCIONA Energía reports that it has reached an agreement with OTRAS PRODUCCIONES DE ENERGÍA FOTOVOLTAICA, S.L.U. (OPDE), for the sale of 100% of several companies within the ACCIONA Energía group that directly own 13 operational wind farms located in Spain with installed capacity totalling 440 MW. The consideration amounts to approximately EUR 530 million. Additionally, the agreement encompasses a portfolio of up to 351MWp of solar pv projects under development, associated to the potential to hybridise the wind farms included in the transaction.

This transaction will generate an estimated result of EUR 190 million to ACCIONA Energía.

The closing of the transaction, which is subject to the compliance of conditions precedent of a regulatory nature, is expected to occur in the second half of the current year.

ACCIONA ENERGÍA TO SELL 440MW OF WIND ASSETS IN SPAIN TO OPDENERGY FOR €530 MILLION

MADRID, JULY 28TH, 2025. ACCIONA Energía has reached an agreement with independent energy producer Opdenergy – backed by private equity firm Antin Infrastructure Partners – for the sale of 440MW of wind assets in Spain, for an estimated €530 million.

The transaction is expected to be completed before the end of the year, following the necessary antitrust and foreign investment clearances, and will generate an estimated result of €190 million.

The portfolio comprises 13 wind farms in the provinces of Albacete, Cádiz, Cuenca, Lérida, Valencia and Zamora with an average age of 15 years.

The agreement also includes a portfolio of photovoltaic projects under development, totalling up to 351MWp, linked to the hybridization potential of the wind farms included in the deal.

The transaction forms part of ACCIONA Energía's asset rotation strategy, designed to enhance the value of its portfolio, strengthen its financial profile, and reinforce its leadership in the global renewable energy sector.

Recent milestones in the asset rotation program include the sale of two hydropower asset portfolios in Spain: 175MW to Elawan Energy and 626MW to Endesa. In addition, last month the company signed an agreement with Luz del Sur, one of Peru's leading energy companies, for the sale of the 136MW San Juan de Marcona wind farm.

BNP Paribas and Baker McKenzie acted as financial and legal advisors, respectively, for the transaction.
