

**Coca-Cola Europacific Partners plc (the “Company”)  
Transactions in Own Shares**

The Company confirms that on 17 March 2026 it purchased a total of: (i) 40,000 ordinary shares of EUR 0.01 (“**ordinary shares**”) on the US Trading Venues<sup>1</sup> and (ii) 20,000 ordinary shares on the London Trading Venues<sup>2</sup>; in both cases, from Goldman Sachs & Co. LLC, Goldman Sachs International or one of their affiliates, as detailed below.

The repurchased ordinary shares will be cancelled.
