In relation to the program to buy-back treasury shares announced by means of other relevant information communication dated April 14, 2021 (registration number 8633) (the "Buy-back Program") and in accordance with article 227 of the recast Spanish Securities Market Act (Ley del Mercado de Valores), approved by Royal Legislative Decree 4/2015 of 23 October and articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052, of 8 March 2016, supplementing Regulation (EU) No 596/2014 of the European Parliament and of the Council, with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures, the Company hereby informs on the transactions carried out under the Buy-back Program during the period between October 12th and October 14th of 2021.

Likewise, we hereby report that on 14 October 2021 the term for the Buy-back Programme expired and, therefore, has been terminated on that date. The Company has acquired, under the Buy-back Programme, a total amount of 3,940,761 own shares, representing 4.50% of Lar España's current share capital, investing a total amount of 20,763,341.91€.

The acquisition of own shares under the Buy-back Program has been carried out and communicated through other relevant information on a regular basis, in accordance with Articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052.



Likewise, the Company informs of the reactivation of the liquidity contract for the management of its treasury stock, signed on 5 July 2017 with JB Capital Markets, Sociedad de Valores, S.A.U. and communicated to the market on 10 July 2017 by means of a relevant event with registration number 254421, which continued to be suspended due to the extension of the Buy-Back Program, in the terms reflected in the communication of other relevant information dated 14 April 2021 (registration number 8633).

Lastly, the Company announces that the own shares acquired under the Buy-Back Program will be redeemed shortly.
