It is hereby communicated that the 2026 General Shareholders' Meeting of Prosegur Cash, S.A. (the "**Company**"), validly held today, 29 April 2026, on first call, approved, with sufficient majority, all the resolutions proposed by the Board of Directors, including the distribution of a dividend out of voluntary reserves, in a gross amount of 0.0424 euros for each share in circulation, which implies a total maximum dividend of 62,465,184.65 euros.

The dividend shall be paid in a single payment, in cash, during the month of December 2026, through the member entities of Sociedad de Gestión de los Sistemas de Registro, Compensación y Liquidación de Valores (IBERCLEAR).

Withholdings taxes will be deducted in accordance with the applicable law, from the gross amounts payable.
