

Coca-Cola Europacific Partners plc (the “Company”)
Transactions in Own Shares

The Company confirms that on 2 October 2025 it purchased a total of: (i) 73,610 ordinary shares of EUR 0.01 (“**ordinary shares**”) on the US Trading Venues¹ from Jefferies LLC, and (ii) 32,994 ordinary shares on the London Trading Venues² from Jefferies International Limited, as detailed below.
