## **Privileged Information**

In relation to the communication of privileged information published by the Company on June 28<sup>th</sup>, 2022 (register number 1510), through which the Company informed that the *Sociedad Estatal de Participaciones Industriales* ("**SEPI**") had informed Abengoa Abenewco 1, S.A.U. ("**Abenewco 1**") that the request for temporary public aid amounting to 249 million euros ("**SEPI Financing**") had been rejected and therefore the ongoing restructuring and consent solicitation process launched by Abenewco 1 to its financial creditors had also been terminated, the Company informs that the Board of Directors of Abenewco 1, in the session held today, in the interest of maintaining continued operations and safeguard the various stakeholders of the group, agreed to present the communication of protections under article 583 of the consolidated text of the insolvency law in order to initiate negotiations with creditors to reach a potential restructuring agreement.
