With reference to the disclosure of other relevant information dated 15 October 2025, under registration number 37196, concerning the Third Tranche of the Share Buyback Programme Framework (in connection with the reduction of Endesa's share capital through the cancellation of treasury shares acquired), and pursuant to the provisions of Article 2 of Delegated Regulation (EU) 2016/1052, which supplements Regulation (EU) No 596/2014 of the European Parliament and of the Council with regard to regulatory technical standards relating to the conditions applicable to buyback programmes and stabilisation measures, Endesa hereby announces that, during the period from 08 to 12 December 2025, the Company has executed the following transactions involving its own shares under the Third Tranche of the Share Buyback Programme Framework:
