

**MELIÁ HOTELS INTERNATIONAL, S.A.** (the "Company"), in compliance with Law 6/2023, of 17 March, on Securities Markets and Investment Services, in relation to article 17 of (EU) Regulation no.596/2014 of the European Parliament and of the Council of 16 April 2014, hereby informs the National Securities Market Commission (CNMV) of the following:

### **OTHER RELEVANT INFORMATION**

As previously announced in Other Relevant Information number 36464, Ms. Ana María Jaume Vanrell, widow of the late Honorary President and Founder of the Company, Mr. Gabriel Escarrer Juliá (RIP), passed away on August 26, 2025.

Today, the companies Hoteles Mallorquines Consolidados, S.L., Hoteles Mallorquines Agrupados, S.L., and Hoteles Mallorquines Asociados, S.L. (the "Commercial Companies") have sent the CNMV and the Company an update on the notifications of significant shareholdings in MHI.

Thus, in line with the succession process reported in the Relevant Facts published by the Company on October 11, 2018, registration numbers 270,438 and 270,439, and on December 12, 2024, registration number 31741, the Company proceeds to transfer the content of the communications received.

#### *Notification of significant shareholdings*

Notifications sent to the CNMV and the Company indicate that, as a result of the death of Ms. Ana María Jaume Vanrell, the Commercial Companies, namely Hoteles Mallorquines Consolidados, S.L., Hoteles Mallorquines Agrupados, S.L., and Hoteles Mallorquines Asociados, S.L., now hold 24.365%, 11.290%, and 13.763%, respectively, the total of the voting rights of MHI.

Similarly, the heirs of Mr. Gabriel Escarrer Juliá (RIP) have indirectly declared 5.388% of MHI's total voting rights through Tulipa Inversiones 2018, S.A.

The Commercial Companies also issue a joint communication with the aggregate result of their direct and individual holdings in the Company, without there being any controlling partner in any of the Commercial Companies, for the purposes of Royal Decree 1362/2007, of October 19, which implements Law 24/1988, of July 28, on the Securities Market, in relation to the transparency requirements regarding information on issuers whose securities are admitted to trading on an official secondary market or on another regulated market in the European Union,.

#### *Shareholders' Agreement*

The Shareholders' Agreement referred to in the Relevant Fact with registration number 270,439 of October 11, 2018, signed by Mr. Gabriel Escarrer Juliá, Ms. Ana María Jaume Vanrell, and their six children (namely, Ms. María Magdalena, Ms. Ana María, Ms. María Antonia, Ms. María

Mercedes, Mr. Sebastián, and Mr. Gabriel Juan Escarrer Jaume), in their capacity as direct or indirect partners of the Commercial Companies, among others, through which they participate in the share capital of MHI, remains unchanged. However, following the death of Mr. Escarrer and his wife, Mrs. Jaume, in accordance with the extract from the Shareholders' Agreement that was communicated in 2018 to the CNMV and MHI, the Shareholders' Agreement takes effect, as applicable, in such a way that, during the initial period of five years from the death of Ms. Ana María Jaume Vanrell, "a reinforced majority of 80% will be required in the decisions taken by the general meetings of the Commercial Companies, [...] to take decisions affecting the reduction of their shareholding in MHI."

#### *Succession process*

These communications are part of the orderly succession process of the Escarrer family. Ms. María Magdalena, Ms. Ana María, Ms. María Antonia, Ms. María Mercedes, Mr. Sebastián, and Mr. Gabriel Juan Escarrer Jaume, as partners in the commercial companies, hope to convey stability and confidence to the remaining shareholders of the company as well as other MHI stakeholders (employees, suppliers, customers, investors, etc.).
