The Company hereby informs that the prospectus relating to the initial public offering of ordinary shares of the Company (the "**Offering**") and the admission to listing of such ordinary shares on the Barcelona, Bilbao, Madrid and Valencia Stock Exchanges (the "**Spanish Stock Exchanges**") (the "**Prospectus**") has been approved and registered by the Spanish Securities and Exchange Commission ("**CNMV**"). The Prospectus, including the key offering statistics (such as the Offering Price of €15.00 per share) and the tentative calendar of the Offering (detailed in section "*Expected Timetable and Offering Statistics*"), is available to investors on the websites of the CNMV ([www.cnmv.es](http://www.cnmv.es)) and Cirsa ([www.cirsa.com](http://www.cirsa.com)).

Each of the dates included in the tentative calendar of the Offering is subject to change without prior notice. Any change will be made public by means of publishing the corresponding inside information notice (*comunicación de información privilegiada*) or an other relevant information notice (*comunicación de otra información relevante*) with the CNMV.

At the end of the bookbuilding period (expected on July 7, 2025), the Company and the Managers are expected to enter into the underwriting and placement agreement relating to the Offering, which will be communicated to the CNMV through an inside information notice (*comunicación de información privilegiada*).

Capitalised terms used but not defined herein shall have the meaning given to such terms in the Prospectus.
