Closing of the first edition of the “Iberdrola Retribución Flexible”
optional dividend system of the fiscal year 2026

Pursuant to article 227 of Act 6/2023, of 17 March, of the *Securities Markets and Investment Services (Ley 6/2023, de 17 de marzo, de los Mercados de Valores y de los Servicios de Inversión)*, and related provisions, and further to our notices of other significant information (*comunicaciones de otra información relevante*) filed with this National Commission on 16 June and 2 July 2026 (with official registry numbers 41,389 and 41,685, respectively) regarding: (i) the implementation of the paid-up capital increase approved by the General Shareholders' Meeting of “Iberdrola, S.A.” (the “**Company**”) held on first call on 29 May 2026 (the “**2026 General Shareholders' Meeting**”) under item 8 on the agenda¹ (the “**Capital Increase**”); and (ii) the supplementary payment to the dividend corresponding to the fiscal year 2025 (the “**Supplementary Dividend**”), and, as the case may be, the payment of the cash adjustment dividend (the “**Adjustment Dividend**”) which were approved by the 2026 General Shareholders' Meeting under item 7 of its agenda and under the Common Terms, both in the context of the first edition of the “Iberdrola Retribución Flexible” optional dividend system of the fiscal year 2026, we hereby inform you that²:

- a) The period for trading the free-of-charge allocation rights corresponding to the Capital Increase ended on 20 July 2026.
- b) During the period established for such purpose, the holders of 1,667,924,179 shares of the Company (which represent 25.368 % of the share capital of the Company) have elected to receive the Supplementary Dividend. As a consequence, the total gross amount of the Supplementary Dividend is 708,867,776.08 euros, which results from multiplying the gross amount of the Supplementary Dividend per share (0.425 euros) by the number of shares whose holders have chosen to receive the Supplementary Dividend (1,667,924,179).

As a result of the foregoing, these shareholders have expressly waived 1,667,924,179 free-of-charge allocation rights and, thus, 33,358,483.58 new shares corresponding to the referred rights. Furthermore, the payment of the Supplementary Dividend has been rendered without effect in respect of the amount which has not been paid to those shareholders who have chosen (expressly or tacitly) any of the remaining options under the "*Iberdrola Retribución Flexible*" optional dividend system.

- c) As indicated in the notice of other significant information (*comunicación de otra información relevante*) filed with this National Commission on 2 July 2026 (with official registry number 41,685), in this edition of the optional dividend system "*Iberdrola Retribución Flexible*": (a) the Total Supplementary Dividend gross per share amounts to 0.427 euros, an amount equal to the Target Dividend; and (b) the payment of the Adjustment Dividend is applicable.

The total gross amount of the Adjustment Dividend amounts to 13,148,563.54 euros, which results from multiplying the total gross Adjustment Dividend amount per share (*i.e.*, 0.002 euros) by the total number of outstanding shares of the Company on the record date (*i.e.*, 7 July 2026) of this first edition of the "*Iberdrola Retribución Flexible*" system for the financial year 2026 (excluding in any event the Company's treasury shares in accordance with the provisions of article 148 of the Spanish Companies Act) (that is, 718,232).

- d) The definitive amount of the Total Supplementary Dividend amounts to 722,016,339.62 euros gross, which results from adding the final amounts of the Supplementary Dividend and the Total Adjustment Dividend referred to above, all in accordance with the provisions set forth in the Common Terms.
- e) Given that the maximum number of shares of the Company to be issued –after deducting the shares which holders have chosen to receive the Supplementary Dividend (waiving the free-of-charge allocation rights to which they were entitled)– was a fraction, the Company has waived 21 free-of-charge allocation rights that it holds in order for the number of new shares ultimately issued in the Capital Increase to be a whole number and not a fraction.
- f) Therefore, the final number of ordinary shares with a unitary par value of 0.75 euros that will be issued in the Capital Increase is 98,141,516, with the nominal amount of the Capital Increase being 73,606,137.00 euros, which entails an increase of 1.493 % over the share capital of the Company prior to the implementation of the Capital Increase. The nominal amount of the Capital Increase has been fully paid up by means of the application of the reserve called "share premium reserve" ("*reserva de prima de emisión de acciones*")
- g) As a consequence, the share capital of the Company after the Capital Increase will amount to 5,004,856,137.00 euros, represented by 6,673,141,516 ordinary shares having a nominal value of 0.75 euros each, fully subscribed for and paid up.
- h) It is expected that, subject to compliance with all legal requirements (particularly, the verification of such compliance by the National Securities Market Commission), the new shares will be admitted to trading on the Madrid, Barcelona, Bilbao and Valencia Stock Exchanges, through the Automated Quotation System (Electronic Market), on Tuesday, 28 July 2026. In this respect, the ordinary trading of the new shares is expected to commence on Wednesday, 29 July 2026.

Additionally, on 27 July 2026 the following payments are expected to be made: (i) the Supplementary Dividend to the aforementioned holders who have elected to receive it; and (ii) the Adjustment Dividend to all shareholders of the Company on the record date (*i.e.*, 7 July 2026) of this edition of the optional dividend system "*Iberdrola Retribución Flexible*" (excluding in any event the Company's treasury shares in accordance with the provisions of article 148 of the Spanish Companies Act).

Likewise, upon the determination of the total gross amount of the Supplementary Dividend, the proposed allocation of profit/loss and payment of the dividend corresponding to the fiscal year 2025 has been specified, fixing the definitive amount of the quantity allocated to dividend and the quantity to be allocated to remainder. Accordingly, the definitive basis for distribution and the proposed distribution of profit/loss (expressed in euros) to which item 7 on the agenda of the 2026 General Shareholders' Meeting refers are as follows:
