Periodic information and termination of the share buy-back programme of “Iberdrola, S.A.”.

Reference is made to our notices of other relevant information of 25 March and 30 May 2025 (with official registry numbers 33,645 and 35,075, respectively), relating to the approval and launch of the buy-back programme of own shares by the Board of Directors of “Iberdrola, S.A.” (the “**Company**”), respectively, in accordance with the authorisation granted by the General Shareholders’ Meeting held on second call on 17 June 2022, under item 19 of the agenda (the “**Buy-back Programme**”).

Pursuant to article 227 of *Act 6/2023, of March 17, of the Securities Market and Investment Services (Ley 6/2023, de 17 de marzo, de los Mercados de Valores y de los Servicios de Inversión)* and related provisions, and in accordance with articles 2.2 and 2.3 of *Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016 supplementing Regulation (EU) No 596/2014 of the European Parliament and of the Council with regard to regulatory technical standards for the conditions applicable to buy-back programmes and stabilisation measures (the “**Regulation 2016/1052**)*, we hereby inform you of the following:

June 2025 and until the end of the trading session of 19 June 2025, the Company has acquired a total of 4,266,831 own shares under the Buy-back Programme, representing 0.066% of the share capital of the Company.

- The Company terminated the Buy-back Programme at the end of today's trading session, date on which, as mentioned in the notice of other relevant information of 30 May 2025 (with official registry number 35,075), the termination of the programme was expected.
- The Company has not acquired nor expects to acquire own shares pursuant to the settlement at maturity of certain derivatives instruments over own shares that were subscribed by the Company before the launching of the Buy-back Programme (the "**Derivatives**").

It is hereby stated that the acquisition of own shares under the Buy-back Programme has been communicated on a regular basis, in accordance with the provisions of articles 2.2 and 2.3 of *Regulation 2016/1052*, and has been carried out pursuant to the terms and conditions established in such regulation.

The execution of the share capital reduction, approved by the General Shareholders' Meeting of the Company on first call 30 May 2025 under item 11 of the agenda (the "**Reduction Resolution**" and the "**Share Capital Reduction**", respectively) is expected to take place within one month from the date of conclusion of the Buy-back Programme (that is, before 19 July 2025). To that effect:

- The Share Capital Reduction will be implemented by means of the retirement of 200,561,000 own shares, representing 3.114 % of the Company's share capital (the "**Maximum Limit**"). As provided in the Reduction Resolution and in order to observe the Maximum Limit in any case, the maximum number of shares to be retired that have been acquired in implementation of the Buy-back Programme and pursuant to the settlement of Derivatives will be subject to an overall limitation (the "**Overall Limit**").

In this regard, if the shares acquired in implementation of the Buy-back Programme and pursuant to the settlement of Derivatives exceed the Overall Limit, the Share Capital Reduction will result in the retirement of: (i) all of the own shares acquired in implementation of the Buy-back Programme; and (ii) with regard to the own shares acquired pursuant to the settlement of Derivatives, a number equal to the difference between the Overall Limit and the shares acquired in implementation of the Buy-back Programme will be retired.

- Given that no shares of the Company have been acquired through the settlement of the Derivatives, and considering the Maximum Limit and the Overall Limit, the Share Capital Reduction will be implemented by means of the retirement of: (i) 4,266,831 own shares, representing approximately 0.066% of the Company's share capital, acquired under the Buy-back Programme; and (ii) 196,294,169 shares held by the Company as treasury shares after the closing of the trading session on 30 May 2025, representing approximately 3.048% of its share capital.
