Reference is made to our notices of other relevant information of 14 March and 28 April 2023 (with official registry numbers 21,343 and 22,261), relating to approval and launch of the buy-back programme of own shares by the Board of Directors of “Iberdrola, S.A.” (the “**Company**”), respectively, in accordance with the authorisation granted by the shareholders acting at the General Shareholders’ Meeting held on second call on 17 June 2022, under item 19 of the agenda (the “**Buy-back Programme**”).
