The acquisition of 60.000 shares of the Company described in the previous paragraph, has taken place independently to the Buy Back Program through a block trade. To date, the Company has not taken any specific decision on the destination of the shares acquired in the referred transaction.

Following the acquisition of the above-mentioned block of shares and the modification of the Buy-back Programme published by the Company through a communication of "other relevant

information" (No. 576) on the 28th of February 2020, the maximum amount of shares targeted by the Buy Back Program is set at **5.189.335**, without deducting the shares already acquired under the Buy-back Programme since its establishment.

If during the term of the Buy-back Programme, the treasury stock reaches 9.99% of the subscribed voting capital (equal to 4,791,862 shares), the Buy-back Programme shall be automatically suspended until the number of Aedas' treasury stock is reduced below the aforementioned percentage of the share capital and by a percentage equal to the number of shares acquired in execution of the Buy-back Programme up to that time.
