Share buy-back, stabilisation and treasury stock programmes

In relation to the program to buy-back treasury shares announced by means of other relevant information communication dated February 28, 2025 (registration number 33145) (the "**Buy-back Program**"), Pharma Mar, S.A. (the "**Company**") hereby informs on the transactions carried out under the Buy-back Program during the period between 16th and 19th June 2025 (the "**Period**").

Likewise, we inform you that, after the last of the above-mentioned acquisitions, the Company reached the maximum number of shares to be acquired under the Buy-back Program, that is, 91,111 shares for a total amount invested of €7,522,002.07, and that, therefore, its termination occurs before the deadline for its effectiveness (set for February 28, 2026). These shares represent 0.5% of the Company's share capital at the date of this communication. The Company will dedicate all of the treasury stock acquired under the Buy-back Program for their redemption, through the execution of the corresponding capital stock reduction.

The acquisition of own shares under the Buy-back Program has been carried out and communicated through other relevant information on a regular basis, in accordance with Articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052.

Additionally, it is hereby communicated that, after the completion of the Buy-back Program, the suspension of the operations regulated in the liquidity agreement entered into the Company and JB CAPITAL MARKETS, SOCIEDAD DE VALORES, S.A.U., which entered into force on June 28, 2021 and whose operation would be effective as from July 13, 2021, as was communicated to the market through other relevant information of this date (with registration number 10,583) will cease. Consequently, these operations will be resumed as from June 23, 2025.
