As a continuation of the notice of other relevant information published on March 1, 2023 (registration number 21110) relating to the establishment of a share buy-back programme, the Company hereby reports the transactions carried out over its own shares between 12 June and 15 June 2023 (both inclusive), under the share buy-back programme approved by the Board of Directors of the Company in accordance with the authorization granted by the General Shareholders’ Meeting.

In addition to the above, Global Dominion Access reports that, after the last of the reported acquisitions, the Company has reached the maximum number of shares (1.526.667, representing approximately 1% of the Company’s share capital) prescribed in the share buy-back programme. The shares have been acquired for a cash amount of EUR 5.8 million, equivalent to an average price of EUR 3.81 per share.

Consequently, it is hereby reported that the share buy-back programme has come to an end prior to its maturity. The purpose of the programme was to purchase shares to reduce the share capital of the Company by the redemption of own shares, with the aim of contributing to the shareholders’ remuneration policy through the increase in earnings per share.

The acquisition of the own shares under the share buy-back programme has been periodically communicated, in accordance with articles 2.2 and 2.3 of Delegated Regulation (EU) 2016/1052.
